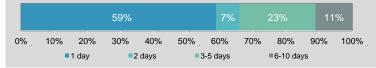

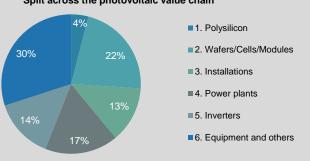
Market capitalisations of the companies
